E-SAFETY POLICY

New technologies have become integral to the lives of children and young people in today's society, both within The Robert Drake Primary School and in their lives outside the school.

The internet and other digital and information technologies are powerful tools, which open up new opportunities for everyone. Electronic communication helps teachers and pupils learn from each other. These technologies can stimulate discussion, promote creativity and increase awareness of context to promote effective learning. Children and young people should have an entitlement to safe internet access at all times.

The requirement to ensure that children and young people are able to use the internet and related communications technologies appropriately and safely is addressed as part of the wider duty of care to which all who work in The Robert Drake Primary School are bound. This e-safety policy will help ensure safe and appropriate use both in and out of school. The development and implementation of this strategy involves all the stakeholders in a child's education from the headteacher and governors to the senior management team, subject manager and classroom teachers, support staff, parents/carers, members of the community and the pupils themselves.

The use of these exciting and innovative tools in The Robert Drake Primary School and at home has been shown to raise educational standards and promote pupil achievement.

However, the use of these new technologies can put young people at risk within and outside The Robert Drake Primary School. Some of the dangers they may face include:

- Access to illegal, harmful or inappropriate images or other content
- Unauthorised access to / loss of / sharing of personal information
- The risk of being subject to grooming by those with whom they make contact on the internet
- The sharing / distribution of personal images without an individual's consent or knowledge
- Inappropriate communication / contact with others, including strangers.
- Cyber-bullying
- Access to unsuitable video / internet games
- An inability to evaluate the quality, accuracy and relevance of information on the internet
- Plagiarism and copyright infringement

- Illegal downloading of music or video files
- The potential for excessive use which may impact on the social and emotional development and learning of the young person
- The risk of being subject to terrorist and extremist material.

Many of these risks reflect situations in the off-line world and this e-safety policy is used in conjunction with other school policies (Behaviour and Anti-bullying, Acceptable Use, Social Media and Child Protection).

As with all other risks, it is impossible to eliminate those risks completely. It is therefore essential, through good educational provision to build pupils' resilience to the risks to which they may be exposed, so that they have the confidence and skills to face and deal with these risks.

The Robert Drake Primary School demonstrates the necessary safeguards to help ensure that we have done everything that could reasonably be expected of us to manage and reduce these risks. The e-safety policy that follows explains how we will do this, while also addressing wider educational issues in order to help young people (and their parents / carers) to be responsible users and stay safe while using the internet and other communications technologies for educational, personal and recreational use.

Roles and Responsibilities

The following section outlines the roles and responsibilities for e-safety of individuals and groups within The Robert Drake Primary School:

Governors:

Governors are responsible for the approval of the E-Safety Policy and for reviewing the effectiveness of the policy. This will be carried out by the Governors receiving regular information about e-safety incidents and monitoring reports. The role of the E-Safety Governor will include:

- · regular meetings with the E-Safety Co-ordinator
- regular monitoring of e-safety incident logs
- regular monitoring of filtering / change control logs
- reporting to relevant Governors meeting

Headteaching and Senior Leaders:

- The Headteacher is responsible for ensuring the safety (including e-safety) of members of The Robert Drake Primary School community, though the day to day responsibility for e-safety will be delegated to the E-Safety Co-ordinator
- The Headteacher / Senior Management Team are responsible for ensuring that the E-Safety Coordinator and other relevant staff receive suitable CPD to enable them to carry out their e-safety roles and to train other colleagues, as relevant
- The Headteacher / Senior Management Team will ensure that there is a system in place to allow for monitoring and support of those in school who carry out the internal e-safety monitoring role
- The Senior Management Team will receive regular monitoring reports from the E-Safety Co-ordinator

 The Headteacher and another member of the Senior Management Team should be aware of the procedures to be followed in the event of a serious e-safety allegation being made against a member of staff.

E-Safety Coordinator/Officer duties:

- Takes day to day responsibility for e-safety issues and establishes and reviews the school's e-safety policies / documents
- They will ensure that all staff are aware of the procedures that need to be followed in the event of an e-safety incident taking place
- They will provide training and advice for staff. This will include the 'Channel' programme that addresses radicalisation
- Liaise with school ICT technical staff
- To receive reports of e-safety incidents and create a log of incidents to inform future e-safety developments
- Meet regularly with E-Safety Governor to discuss current issues, review incident logs and filtering / change control logs
- Attend relevant meeting / committee of Governors
- Report regularly to Senior Management Team.

Technical Staff:

The Systems Manager / ICT Technician / ICT Co-ordinator is responsible for ensuring:

- that the school's ICT infrastructure is secure and is not open to misuse or malicious attack
- that the school meets the e-safety technical requirements outlined in any relevant E-Safety Policy and guidance
- that users may only access the school's networks through a properly enforced password protection policy, in which passwords are regularly changed
- The Senior Management Team are informed of issues relating to the filtering applied by the network
- that he / she keeps up to date with e-safety technical information in order to effectively carry out their e-safety role and to inform and update others as relevant
- that the use of the network / remote access / email is regularly monitored in order that any misuse / attempted misuse can be reported ICT Co-ordinator for investigation
- that monitoring software / systems are implemented and updated as agreed in school policies

Teaching and Support Staff

Are responsible for ensuring that:

- they have an up to date awareness of e-safety matters and of the current school e-safety policy and practices
- they read, understand and sign the school Staff Acceptable Use Policy (AUP)
- they report any suspected misuse or problem to the ICT Co-ordinator for investigation
- digital communications with pupils should be on a professional level and only carried out using official school systems

- e-safety issues are embedded in all aspects of the curriculum and other school activities
- they report any suspected use of terrorist or extremist ideas originating from computer access. This information will then be referred to the head teacher.
- students / pupils understand and follow the school e-safety and acceptable use policy
- they monitor ICT activity in lessons, extra curricular and extended school activities
- they are aware of e-safety issues related to the use of mobile phones, cameras and hand held devices and that they monitor their use and implement current school policies with regard to these devices
- in lessons where internet use is pre-planned pupils should be guided to sites checked as suitable for their use and that processes are in place for dealing with any unsuitable material that is found in internet searches

<u>Designated Safeguarding Person</u>

Should be trained in e-safety issues and be aware of the potential for serious child protection issues to arise from:

- sharing of personal data
- access to illegal / inappropriate materials
- inappropriate on-line contact with adults / strangers
- · potential or actual incidents of grooming
- cyber-bullying

Pupils

- are responsible for using the school ICT systems in accordance with the Acceptable Use Policy
- have a good understanding of research skills
- need to understand the importance of reporting abuse, misuse or access to inappropriate materials and know how to do so
- will be expected to know and understand school policies on the use of mobile phones, digital cameras and hand held devices. They should also know and understand school policies on the taking / use of images and on cyber-bullying
- need to understand the risks associated with terrorism and develop the knowledge and skills to be able to challenge extremist views
- should understand the importance of adopting good e-safety practice when using digital technologies out of school and realise that the school's E-Safety Policy covers their actions out of school, if related to their membership of the school.

Parents/Carers

Parents / Carers play a crucial role in ensuring that their children understand the need to use the internet / mobile devices in an appropriate way. The Robert Drake Primary School will take every opportunity to help parents understand these issues through parents' evenings, newsletters, letters, website and information about esafety campaigns. Parents and carers will be responsible for:

- endorsing (by signature)
- accessing the school website / on-line pupil records in accordance with the relevant school Acceptable Use Policy

Policy Statements

Education-Pupils

Whilst regulation and technical solutions are very important, their use must be balanced by educating pupils to take a responsible approach. The education of pupils in e-safety is therefore an essential part of the school's e-safety provision. Children and young people need the help and support of the school to recognise and avoid e-safety risks and build their resilience.

E-Safety education will be provided in the following ways:

- A planned e-safety programme will be provided as part of ICT / PHSE / other lessons and should be regularly revisited – this will cover both the use of ICT and new technologies in school and outside school
- Key e-safety messages will be reinforced as part of a planned programme of assemblies and activities
- Pupils will be taught in all lessons to be critically aware of the materials / content they access on-line and be guided to validate the accuracy of information
- Pupils will be helped to understand the need for the pupil AUP and encouraged to adopt safe and responsible use of ICT, the internet and mobile devices both within and outside school
- Through the promotion of British Values the pupils will be taught to challenge extremist views when using material accessed on the internet
- Pupils will be taught to acknowledge the source of information used and to respect copyright when using material accessed on the internet
- Rules for use of ICT systems / internet will be posted in all rooms and displayed on logon screens
- Staff will act as good role models in their use of ICT, the internet and mobile devices

Education – Parents/Carers

Many parents and carers have only a limited understanding of e-safety risks and issues, yet they play an essential role in the education of their children and in the monitoring / regulation of the children's on-line experiences.

The Robert Drake Primary School will therefore seek to provide information and awareness to parents and carers through:

- · Letters, newsletters, web site,
- Parents meetings
- Reference to websites (e.g. UK Safer Internet Centre)

Education and Training - Staff

It is essential that all staff receive e-safety training and understand their responsibilities, as outlined in this policy. Training will be offered as follows:

A planned programme of formal e-safety training will be made available to staff.
An audit of the e-safety training needs of all staff will be carried out regularly. It is

- expected that some staff will identify e-safety as a training need within the performance management process.
- All new staff will receive e-safety training, ensuring that they fully understand the school's e-safety policy and Acceptable Use Policies
- The E-Safety Coordinator will receive regular updates through attendance at training sessions and by reviewing guidance documents.
- This E-Safety policy and its updates will be presented to and discussed by staff in staff meetings and INSET days.
- The E-Safety Coordinator will provide advice, guidance and training as required to individuals as required

Training - Governors

Governors should take part in e-safety training sessions;

Participation in school training / information sessions for staff or parents

Technical - Infrastructure/equipment, Filtering and Monitoring

The school will be responsible for ensuring that the school network is as safe and secure as is reasonably possible and that policies and procedures approved within this policy are implemented. The filtering system in place in managed by the Local Authority. It will also need to ensure that the relevant people named in the above sections will be effective in carrying out their e-safety responsibilities:

- School systems will be managed in ways that ensure that the school meets the esafety technical requirements outlined in the E-Safety Policy and Acceptable Use Policy and any relevant guidance.
- There will be regular reviews and audits of the safety and security of school systems.
- Servers, wireless systems and cabling must be securely located and physical access restricted.
- All users will have clearly defined access rights to school systems.
- All users will be provided with a username and password.
- The "administrator" passwords for the school system must be available to the Headteacher and kept in a secure place.
- Users will be made responsible for the security of their username and password, must not allow other users to access the systems using their log on details and must immediately report any suspicion or evidence that there has been a breach of security.
- Any filtering issues should be reported immediately to the Local Authority.
- Requests from staff for sites to be removed from the filtered list will be considered by the Headteacher and Computing Co-ordinator.
- An appropriate system is in place (CEOP Reporting Button) for users to report any actual / potential e-safety incident.
- Appropriate security measures are in place to protect the servers, firewalls, routers, wireless systems, work stations, hand held devices etc from accidental or malicious attempts which might threaten the security of the school systems and data.

- An agreed policy is in place, Acceptable Use Policy, regarding the extent of personal use that users and their family members are allowed on laptops and other portable devices that may be used out of school.
- An agreed policy is in place, Computing Policy, regarding the use of removable media (eg memory sticks / CDs / DVDs) by users on school workstations / portable devices
- The school infrastructure and individual workstations are protected by up to date virus software
- Personal data can not be sent over the internet or taken off the school site unless safely encrypted or otherwise secured.

Data Protection

Staff must ensure that they:

- At all times take care to ensure the safe keeping of personal data, minimising the risk of its loss or misuse.
- Are aware of the risks posed by the online activity of extremist and terrorist groups.
- Use personal data only on secure password protected computers and other devices, ensuring that they are properly "logged-off" at the end of any session in which they are using personal data.
- Transfer data using encryption and secure password protected devices.

When personal data is stored on any portable computer system, USB stick or any other removable media:

- The data must be encrypted and password protected.
- The device must be password protected using the memory stick provided by The Robert Drake Primary School.
- The device must offer approved virus and malware checking software.
- The data must be securely deleted from the device once its use is complete.
